Robert Almonte was the United States Marshal for the Western District of Texas from 2010 to 2016. He had previously retired from the El Paso, Texas, Police Department after 25 years of service. He spent most of his career in narcotics investigations and retired as a Deputy Chief.




As the Narcotics Commander with the EPPD, he championed innovative programs like the Hotel/Motel Narcotics Interdiction Unit and the West Texas High Intensity Drug Trafficking Area Stash House Task Force. He has been interviewed by numerous national and international news media outlets about cartels and gangs.
